

# The Livingston Award

## *Call for Nominations*

Nominations for the Livingston Award are now being accepted. The Livingston Award was established in 1988 in memory of J. Arlo Livingston, an Alaska pioneer helicopter pilot, past president of the Helicopter Association of America (now HAI), and charter member of the Men's Auxiliary of the Whirly-Girls. The award is given to honor a woman who has achieved distinction for the contributions she has made on behalf of women in helicopter aviation.

The Livingston Award, founded by Whirly-Girl #4 Nancy Livingston, is given annually to a living woman helicopter pilot, a member of the Whirly-Girls, who personifies the high standards and ideals of women in helicopter aviation, and who has contributed in a significant way to the advancement, recognition and credit of women in helicopter aviation.
